- A. Cheques in payment of Licence Fees must be made payable to the Financial Services Director. If payment is made by post it should be addressed to Financial Services Director, P O Box 653, Bulawayo. If however payment is made in person or by messenger then payment must be made at the Financial Services Director's Licence Section, 8<sup>th</sup> Avenue/J. Tongogara Street.
- B. Trading Permits are issued for not more than three months withing the discreation of the Revenue Officer. If the Trading Permit is required for special purposes, other than envisaged in the application form over- leaf, the reason must be given.
- C. The Trading Permit will be issued to expire at the end of the month following the day of the Licensing Authority's meeting.
- D. If circumstances warrant, an application for renewal of any Trading Permit issued, a fresh application form must be completed and submitted.
- E. The fee for a Trading Permit is \$10.00 for each calendar month embraced ty the Permit and must accompany this application.
- F. A Trading Permit is not available to condone past trading without any Licences and regardless of any Police action that may be pending. A Current Trading Permit may not be considered until full Licence fees and penalties thereon have been lodged on deposit with Revenue Office.

## WARNING:

Trading is not permitted without proper Licence cover and failure to renew the Licence applied for overleaf, to cover continued trading will make the person responsible liable for prosecution without further warning.
