(1) All plans must be submitted in Triplicate, and shall be coloured as follows:

<u>Block Plans</u> – Bricks, red, concrete, green: wood (in section), burnt sienna or burnt umber: wood (in floors and elevation) yellow; impervious floors, grey: iron or steel, blue; existing work, black or neutral tint. Scale not less than 1.100

- (2) Plan fees must be paid at the time of submission.
- (3) C.E form 100 must be completed and submitted for Town Planning Approval (as and when applicable).
- (4) Building Inspectorate Form 45 must be completed and submitted if structural steelwork or reinforced concrete or reinforced brickwork is to be used.
- (5) If employees are to be housed on the premises, application must be made on Building Inspectorate Form 69.
- (6) Pavement levels where applicable must be obtained from the City Engineer's Department.
- (7) No work is to be commenced until plans are approved.
- (8) A copy of the approved plan is to be kept on the works at all times.
- (9) The approval of this plan does not override any restrictive conditions contained in the Title Deeds concerned.
- (10)Inspection and Completion Notices Building Inspectorate Form 17 are to be completed and returned on due date.
- (11) Special permits are required for Hoarding, Scaffolding, Balconies, Canopies, Sun blinds, Advertising Signs and Builder's sheds.
- (12) You are warned of the possibility of damage to your property by storm water, for which the Council cannot accept responsibility.
- (13) Your attention is drawn to the Electrical Department's requirements for Sub-Stations if the connected loads exceed 100kw.
- (14) Electrical cables etc., Builders and others are hereby cautioned that person damaging Paving, Kerbs, or Street Gutters or interfering with Electrical Cables etc., either above or below the ground, will be prosecuted and held liable for damages.
